# Stay at Home With On My Own

### **Services Provided**

### **Community Options Counseling**

Once you have let the nursing home know that you are interested in moving back into the community, our Independent Living Specialist (ILS) will meet with you and provide information on the available resources in your local community. They will also assist you with information on housing options, financial supports and support systems that are available to you. You are allowed to have another person present, such as a friend or family member, during the options counseling session. Our ILS will also meet with the nursing home staff to discuss any concerns they may have with your desire to transition back into the community. A referral is made to the Department of Senior & Disability Services to determine if there is funding available to assist you in your transition process.

#### **MFP Transition Coordination**

Once you have been approved for MFP Transition Funding, our ILS will begin working with you on developing your transition plan back into the community. They will assist you in finding things such as: accessible housing, personal attendant care, medical supports, transportation, adaptive equipment, financial information/supports and indentifying your individual support system.

You may receive up to \$2,400 to assist you in your transition process. Funding can be used on things such as:

- o Rent & Utility Deposits
- o Cleaning Supplies
- o Toiletries
- Household Items
- o Furniture
- o Groceries (1x only)
- o Home & Vehicle Modifications
- o Durable Medical Equipment



## **Eligibility Criteria for MFP Transition**

- o Currently residing in a skilled nursing facility for a period of not less than ninety consecutive days.
- Eligible for Medicaid benefits for at least one day while residing in the nursing facility.
- o Eligible for Medicaid benefits after transition to the community
- o Moving to qualified housing in which the health and welfare of the individual can be assured.
- Eligible for Home and Community Based Services, and meet nursing facility level of care. Agreeable to the terms set forth in the MFP Participation Agreement, which must be signed by the participant.
